**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF DILLON ADOPTING THE FISCAL YEAR 2017-2018 CITY BUDGET FOR DILLON SID #34-PAVING DEW AREA OF THE CITY OF DILLON, MONTANA AND LEVYING ASSESSMENTS THEREFORE**

**WHEREAS**, the City Council of the City of Dillon is the governing body of the City; and

**WHEREAS**, the Council has reviewed and completed a preliminary budget for fiscal year 2017-2018, and a preliminary budget for Dillon SID #34-Paving DEW Area of the City of Dillon, Montana and assessment; and

**WHEREAS**, the City Council published notice of the Hearing on the adoption of the Budget for Dillon SID #34-Paving DEW Area of the City of Dillon, Montana and levying assessment on August 9, 2017 and August 16, 2017; and

**WHEREAS**, the City Council held the noticed hearing on August 16, 2017 and held the regular meeting on the adoption of the preliminary budget and levying assessment at the scheduled time on September 6, 2017.

**NOW THEREFORE BE IT RESOLVED THAT**, the 2017-2018 Preliminary Budget as proposed for Dillon SID #34-Paving DEW Area of the City of Dillon, Montana is hereby adopted.

**BE IT FURTHER RESOLVED THAT**, the assessments as set out in the preliminary budget for Dillon SID #34-Paving DEW Area of the City of Dillon, Montana is hereby assessed for Dillon SID #34-Paving DEW Area of the City of Dillon, Montana to raise an estimated Seventy-Seven Thousand, Three Hundred, Two and 54/100 dollars (\$77,302.54), all as more particularly set out in the appendix hereto describing the property and levying the assessment against it.

**BE IT FURTHER RESOLVED THAT**, the assessment hereby levied is a lien upon all of the property assessed from the date hereof until paid.
